4. August 23 Consultation Panel meeting planning

- The meeting will be held at Chula Vista Public Works office at 1:30pm.

- During the week of August 1, the CP members were sent the Otay Hydromodification Exemption study drafted by Tory R. Walker Engineering, as well as the review memorandum conducted by Amec Foster Wheeler. Written comments of the study and the memo were requested by Friday, August 19.
 - The stance of the Copermittees for San Diego Bay WMA is the study meets the requirements for exemption and if in agreement, it should move forward through the process.

- If the Otay Hydromodification Study is accepted, the next steps are to update the BMP Design Manual and the Watershed Management Area Analysis (WMAA) as an attachment to the WQIP.
 - Once the study is submitted, the Regional Board has 90 days to reject it or comments on it; if there are no comments, then it's approved after 90 days.

A. Agenda

- Initial introductions will be made.
- 5-10 minutes: Background information on the San Diego Bay Watershed Management Area (WMA), the Water Quality Improvement Plan (WQIP), development, the annual reporting process and the history of the eastern Otay River Reach hydromodification exemption status.
- Explanation of the meeting purpose and introduction to the Otay Hydromodification Exemption Study
 - The study is now undergoing the annual reporting process to determine if it meets the criteria for exemption as part of the annual reporting process for the WQIP.
 - The CP meeting is to jumpstart the annual reporting process s

- CP discussion to follow the presentation.
- At least 10 minutes should be allotted for comments from public, including developers.
- Closing remarks will include a "Next Steps" portion that will give bigger picture of the potential adoption of the exemption, Annual Report, and any changes to the WQIP.
